Heard:

Aleš Zalar who informed the Advisory Group of Experts (hereinafter – the Advisory Group) has completed the assessment of the compliance of candidates for the position of judge of the Constitutional Court of Ukraine, who were admitted to the competitive selection by the Council of Judges of Ukraine and the Committee of the Verkhovna Rada of Ukraine on Legal Policy, with the criteria of high moral qualities and recognized level of competence in the field of law and, according to the law "On the Constitutional Court of Ukraine", Methodology for Assessing Moral Qualities and the Level of Competence in the Field of Law of the Advisory Group of Experts approved by the Minutes No. 2 of the meeting of the Advisory Group of Experts of December 04, 2023, is to form a general list of all assessed candidates for the position of judge of the Constitutional Court of Ukraine in an alphabetical order.

Accordingly, Aleš Zalar announced the general list of all assessed candidates for the position of judge of the Constitutional Court of Ukraine in an alphabetical order, admitted to the competitive selection by the Council of Judges of Ukraine, namely:
